

## **ZEROBODY QUOTE REQUEST FORM INFORMATIONS**

### **INFORMATIVA PER LE PERSONE FISICHE AI SENSI DELL'ART.13 DEL REGOLAMENTO UE 679/2016**

EU Regulation 679/2016 provides for the right to the protection of personal data concerning natural persons. In compliance with this legislation, our Company informs you of the following:

**Purposes of data processing:** the processing of personal data relating to you is intended to enable the company Data Controller and its employees and/or partners in charge to carry out the following activities:

- 1. Preparation of the quote and management of the resulting relationships:** consent is not required and the legal basis for the processing of data for this purpose is the execution of a contract (art.6.1 lett, b) GDPR).
- 2. Obligations of the law,** regulations, national and EU regulations as well as provisions issued by authorities empowered by law: consent is not required and the legal basis of data processing for this purpose is the fulfillment of obligations under the law and applicable regulations (art.6.1 lett, c) GDPR).
- 3. Sending material and newsletters for advertising purposes:** except in the case of sending information about services and/or products similar to those already purchased (*soft spam* ex art.6.1 lett. f) and recital 47 GDPR) and subject, in any case, to the right of opposition at any time of the customer ex art.22 GDPR: prior consent is required and the legal basis for the processing of data for this purpose is the consent itself (art.6.1 lett. a) GDPR).
- 4. Internal statistics for aggregate data:** consent is not required and the legal basis for data processing for this purpose is the legitimate interest of the owner (art.6.1 lett, f) GDPR).

In relation to the processing of your personal data marked with (\*) for the purposes referred to in points 1) and 2), the provision of your data is mandatory and refusal to provide them makes it impossible to execute the request for an estimate and the management of the contractual relationship. In particular, we would like to inform you that the completion of the fields "Country" and "City" is necessary in order to correctly address you to our staff divided operationally by geographical areas.

In relation, however, to the purposes referred to in points 3) and 4) the provision of data is not compulsory and does not affect the satisfaction of your request.

**Method of data processing:** the data is processed in both paper and electronic form, in compliance with the security measures referred to in art.32 GDPR.

**Dissemination, transfer of data outside the EEA and communication:** unless required by a law or regulation or Community legislation, your personal data are not subject to dissemination and are not subject to transfer outside the territory of the European Union except, in any case, compliance with all legal requirements. The subjects to whom your personal data may be communicated are the following:

1. external subjects who may carry out tasks on behalf of our companies to which the Data Controller should entrust certain activities in outsourcing (e.g.: accountants, consultants) or producers of software and/or platforms necessary for the execution of the contract;
2. credit institutions for the management of payments and collections arising from the execution of contracts;
3. professionals, in order to study and resolve any legal problems relating to your contractual position (e.g.: lawyers);
4. other subjects foreseen by the law.

It should be noted that the company Starpool S.r.l. is not subject to the obligation to appoint a Data Protection Officer provided for in art. 37 of the Regulation (Data Protection Officer - DPO).

**Period of data retention:** Your data will be kept for a maximum of 10 years (ten) from the termination of the contractual relationship for the purposes referred to in paragraphs 1) and 2); until revocation of consent for the purpose referred to in paragraph 3); for a maximum of one year for the purpose referred to in paragraph 4) for the sole purpose of allowing the aggregation of data. Your right to obtain at any time the cancellation or limitation of the use of the data is always reserved where this does not conflict with a precise legal obligation (art.2220 c.c., art.43 D.P.R. 600/73) and subject to our legitimate interest if prevailing.
